The property briefly comprises of an open plan living area with kitchen space, a three piece bathroom and two well proportioned bedrooms. Kitchen comprising of wall & base units incorporating a bowl sink with mixer tap and an integrated electric hob unit with oven. Three piece bathroom comprising of a standard WC, wash basin and a bathtub fitted with a shower mixer.

Externally, there is a communal front yard and rear private parking.

The property is unfurnished and comes with an integrated electric hob unit with oven, integrated fridge and window blinds.

One month rent and five weeks deposit are payable. References and guarantor may be required.

All bills are payable by the tenant.

No smoking permitted inside the property.

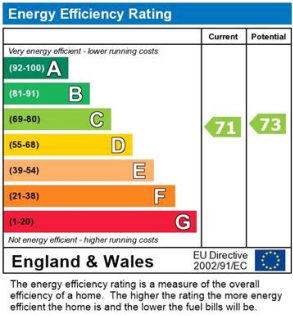
